2008, Happy New Year!

Propagation of the O'Daimoku in Nevada will begin on the New Year's Day with the sunrise chanting at Red Rock Canyon. The first official blessing for visitors will be held at 10:30a.m. at the Nichiren Buddhist Kannon Temple of Nevada. Everyone is welcome!

Since moving to Las Vegas, I wake up early in the morning and worship the morning star (Venus) and the moon in my backyard. I chant the Odaimoku, "Name Myoho Renge Kyo." After a short rest, I go for a walk to a park before sunrise. I chant "Jiga-ge" from chapter 16 in the Lotus Sutra and a phrase from chapter 21, "As the rays of the sun and the moon eliminate all darkness of the world, this person takes away sufferings of all people." After coming home I do the morning service.

As you know the rays of the sun, the moon and the stars illuminate darkness and give energy to all living beings, I would like to bring happiness and harmony to everyone who visits the Kannon Temple. People call Las Vegas "Sin City"; I wish and pray that this city will become the Buddha Land.

I am working on obtaining non-profit organization status from the State of Nevada as well as trying to be designated as tax exempted from the IRS. After receiving the tax exemption number, I will donate all of my Buddhist statues, altar materials and office equipments to the temple. One of the Buddhist statues is a Juichimen (Eleven Faces) Kannon Bodhisattva (deity of compassion) that was donated to me by a devoted follower in Japan. The statue is made from *Yakusugi* (a cedar tree more than three thousand and five hundred years old, grown in Yakushima Island in Southern Japan).

Faith in the Deity Kannon is very popular among many non-Nichiren Shu Buddhists in Southeast Asia and some Americans. Actually the compassion of Kannon Bodhisattva is revealed in Chapter 25 of the Lotus Sutra. As the result of my long missionary work in America, I believe that it is easier for general public to visit a Kannon Temple than it is to a Nichiren Shu Temple.

When we get the tax exemption number, I will start the fund-raising for a new temple site and a new building since the present temple is only a residential house now.

Why I Chant the Odaimoku
